Outdoor Contact Sports Opt-In Form

Updated 2/16/2021

This form is to be used by a school located in a county designated as High Risk or Extreme Risk to notify of its intent to opt in to offer outdoor contact sports for the 2020-21 school year in accordance with the Governor’s February 10, 2021 update to [Outdoor Contact Sports Guidance](#). Once final, this form will be posted to a school or district website and a link to it will then be sent to ODE.

In Lower Risk and Moderate Risk counties, practices and games for outdoor contact sports, including high school football, can resume following health and safety guidance to be issued by the Oregon Health Authority.

In High Risk and Extreme Risk counties, where COVID-19 remains more widespread, schools and other sports organizations can opt-in to resuming outdoor full contact sports with additional protocols in place. In such counties, sports organizations must offer on-site responsive testing for symptomatic individuals and close contacts, contact information for contact tracing, and a waiver identifying health and safety risks and a commitment to isolation and quarantine if exposed to COVID-19. Schools in Extreme and High Risk counties must also have at least limited in-person instruction occurring, with the goal of achieving hybrid or full in-person instruction for students this school year. Schools must also be in compliance with state guidance for COVID-19 testing.

On-Site Testing for Symptomatic Individuals and Close Contacts

Plan Details for On-Site Testing for Symptomatic Individuals and Close Contacts

Bandon High School will offer on-site responsive testing for symptomatic individuals and those with known exposures to individuals with COVID-19, this applies to athletes and support staff and volunteers.

Coaches should screen athletes prior to traveling to another school. If symptoms develop en route to the contest the player should self-report to the Coach. The Coach will then communicate the development of symptoms and ask the player to consent to testing. Regardless if the player consents to testing, they will not be allowed to participate in the contest if they are exhibiting COVID-19 symptoms.

COVID 19 Testing Procedure for symptomatic individuals and close contacts for **Bandon High School**

1. The player will self-report to the Athletic Director or Coach. The person hearing the concern will ensure the concern is brought the Athletic Director.

2. The person with symptoms and/or exposure (student or staff) will be give an extra facial covering (mask) to double up on facial coverings. The Athletic Director (the person receiving the concern) will immediately double up on facial coverings.
3. The person will be walked to the designated testing area (parking lot adjacent to BHS gymnasium) following social distancing guidelines.
4. The person will be asked to stay in the designated testing area. The Athletic Director will ask if the person gives consent to be tested. If yes, proceed with the test. If no consent, the athlete, coach, volunteer will not be allowed to participate and/or join in the contest.
5. The AD will then go back to their office and contact the parents (if the person was a student) for an immediate pick up.
6. The person (student or staff) will have to go home no matter if the test is positive or negative.
7. The tester will conduct the test in the designated testing area and not go into the room if possible.
8. Once the test is complete, the AD will present results to the person.
9. The Athletic Director will then report the results of the test on the testing log. The Athletic Director will complete the recording form for the state.
10. If the test is positive, the person will have to be quarantined for 14 days. The tester will begin contact tracing and notify the LPHA.
11. If test is negative, the person will be sent home for the day and reevaluated upon return to school.
12. Once the person has left the designated testing area, the tester will clean and sanitize the area.

Plan Details for Contact Information for Contact Tracing

Bandon School District is committed to collecting contact information for the purpose of contact tracing for each participant, coach, official, staff member, spectator, etc. for each outdoor contact sports practice and contest.

Bandon will utilize COVID-19 Participant/Coach Monitoring form for participation in practices and contents that will include the following information:

- Name of student/player/coach/official
- Drop Off time
- Participant/Coach Telephone number
- Emergency contact & phone number

Any known symptoms/information including:

Temperature of 100.4, fever in the last 48 hours, cough, shortness of breath, close contact with anyone with COVID-19, Last time traveling out of state, pick up time.

Student-Athlete Waiver

OHA Requirements

- The school must have a waiver completed for each student-athlete prior to outdoor contact sports participation identifying health and safety risks and a commitment to isolation and quarantine if exposed to COVID-19.
