BHS DISCIPLINE GUIDELINES

The following discipline guidelines are in place so that students have a clear understanding of the consequences of misbehavior at school. The guidelines will also enable the staff and Administration to be consistent and fair in their disciplinary decisions. As every disciplinary case may be unique, or the severity of the case may be different, the Administration reserves the right to implement a different disciplinary approach when the circumstances warrant it.

Major Problem Behavior	Definition	Consequence
Arson	Student plans and/or participates in malicious burning of property.	Suspension pending expulsion hearing
Bomb Threat/False Alarm	Student delivers a message of possible explosive materials being on-campus, near campus, and/or pending explosion.	Suspension pending expulsion hearing
Defiance/Disrespect/ Insubordination	Student refuses to follow directions, talks back and/or delivers socially rude interactions.	Removal from class to suspension
Disruption	Student engages in behavior causing an interruption in a class or activity. Disruption includes sustained loud talking, yelling, or screaming; noise with materials; horseplay or roughhousing; and/or sustained out-of-seat behavior.	Removal from class to suspension
Dress Code Violation	Student repeatedly wears clothing that does not fit within the dress code guidelines practiced by the school.	Warning to parent contact (and requirement to change.)
Fighting	Student is involved in mutual participation in an incident involving physical violence.	In-school suspension and possible police notification to suspension.
Forgery/Theft	Student is in possession of, having passed on, or being responsible for removing someone else's property or has signed a person's name without that person's permission.	Detention to out of school suspension. Restitution. Possible police notification.
Gang Affiliation Display	Student uses gestures, dress, and/or speech to display affiliation with a gang.	Referral to out of school suspension.

Harassment/Bullying	Student delivers disrespectful messages*(verbal, written or gestural) to another person that includes threats and intimidation, obscene gestures, pictures, or written notes. *Disrespectful messages include negative comments based on race, religion, disabilities, gender, sexual orientation, age, and/or national origin; sustained or intense verbal attacks based on ethnic origin, disabilities or other personal matters.	In-school suspension to suspension pending expulsion hearing. Possible police notification. District Office notification.
Inappropriate Display of Affection	Student engages in inappropriate, consensual, verbal and/or physical gestures/contact of a sexual nature to another person.	Lunch detention to suspension.
Inappropriate Language	Student delivers verbal messages that include swearing, name calling or use of words in an inappropriate way.	Removal from classroom to suspension
Inappropriate Location	Student is in an area that is outside of school boundaries.	Lunch detention to suspension.
Lying/Cheating/ Plagiarism	Student delivers a message that is untrue and/or deliberately violates rules. Giving or receiving answers, non-authorized possession of teacher materials, copying from the internet or another's document.	Lunch detention to suspension. Zero on assignment.
Physical Aggression/ Aggressive Behavior	Student engages in actions involving serious physical contact where injury to self or others may occur (e.g., hitting, punching, kicking, hair pulling, scratching, etc.)	Detention to suspension pending expulsion hearing. Possible police notification.
Property Damage/Vandalism	Student participates in an activity that results in destruction or disfigurement of property.	Lunch detention to suspension pending expulsion. Restitution. Possible police notification.
Skip Class	Student is more than 10 minutes late to class without an excuse or leaves or misses class without permission.	Lunch detention to in-school suspension.
Truancy	Student is chronically more than 15 minutes late to school without an excuse.	Lunch detention to in-school suspension.

Tardy	Student is less than 10 minutes late to class without an excuse. Student must be in the classroom when the bell rings.	Verbal warning to after-school detention.
Technology Violation	Student engages in inappropriate use of cell phone, music device, camera, and/or computer/Chromebook.	See BHS Technology Expectations (below).
Use/Possession of Alcohol	Student is in possession of or is using alcohol.	See BHS Alcohol and Drug Policy (below).
Use/Possession of Drugs	Student is in possession of or using illegal drugs/substances or imitations.	See BHS Alcohol and Drug Policy (below).
Use/Possession of Tobacco and or vapes.	Student is in possession of or using tobacco and/or vape-type devices.	See BHS Tobacco/Vaping Policy (below).
Use/Possession of Combustibles	Student is in possession of substances/objects readily capable of causing bodily harm and/or property damage (matches, lighters, firecrackers, gasoline, lighter fluid, etc.).	In-school suspension pending expulsion. Possible police notification.
Use/Possession of Weapons	Student is in possession of knives or guns (real or look alike), or other objects readily capable of causing bodily harm.	Out of school suspension pending expulsion hearing. Police notification.

Administration reserves the option to recommend expulsion at any point in the process.

BANDON SCHOOL DISTRICT #54 IS A DRUG-FREE ZONE

Bandon School District is a drug and weapon-free school district. Our mission promotes the health, safety, and education of the whole student. We promote preventative programs including health education, physical education, and conflict resolution. Please see below for our Tobacco/Vaping and Alcohol/Drug policies. Any possession of a weapon (real or look alike) may result in an out of school suspension pending an expulsion hearing, as well as notification of local law enforcement.

Bandon High School Tobacco/Vaping Policy

Student possession, use, sale or distribution of tobacco in any form, or a tobacco burning device, on school premises, including buses, or at any school sponsored activity, including preseason and postseason practices or activities is prohibited. Violations of this policy will result in the following procedures: Note: First, second, and third offenses will follow the student from 9th grade to 12th grade. It will not start over at the beginning of each academic year. Any third party evaluations will be at the parent's expense. The administration reserves the option to recommend expulsion at any point of the process.

First Offense:

Police notification.

Meeting with the principal, including a phone call to parents.

Two day in-school suspension.

Two week (14 calendar days) activity suspension, including all school-sponsored activities, athletics and extra-curricular events.

Third party alcohol/drug evaluation may be recommended.

Second Offense:

Police notification.

Meeting with the principal and parents.

Four day in-school suspension.

Seven week (50 calendar days) activity suspension, including all school-sponsored activities, athletics and extra-curricular events.

Third party alcohol/drug evaluation may be recommended.

Third Offense:

Police notification.

Possible out of school suspension.

Activity suspension, including all school-sponsored activities, athletics and extra-curricular events; duration determined by administration.

Third party alcohol/drug evaluation may be recommended.

Bandon High School Alcohol and Drug Policy

Student possession, use, sale or distribution of alcohol, any unlawful drug, drug paraphernalia, or any substance purported to be a drug, including misuse of non-prescription drugs or misuse of drugs prescribed by a licensed medical practitioner, on school premises including buses or at any school-sponsored activity,

including preseason and postseason practices or activities is prohibited. Violations of this policy will result in the following procedures:

First Offense:

Police notification.

Up to 10 day in school suspension. (May be reduced in half with agreement to enter into drug and alcohol counseling at parent's expense).

Two week (14 calendar days) activity suspension, including all school-sponsored activities, athletics and extra-curricular events.

Any third party evaluations will be at the parent's expense.

Second Offense:

Police Notification.

Suspension pending possible expulsion.

Third party evaluation at parent's expense will be required before returning to school.

HARASSMENT AND BULLYING POLICY

Our goal at BHS is to provide an environment free of all forms of harassment. Sexual harassment, sexual intimidation, bullying, cyberbullying, general harassment, intimidating, and hazing of any form has a detrimental effect on the lives and/or education of students and employees. Therefore, it is the policy of Bandon School District to maintain learning and working environments free from all types of discrimination including all forms of harassment and intimidation. These policies cover all forms of harassment (including with electronic devices). Our building administrator and Title IX Coordinator should be contacted for issues related to harassment/bullying.
